



Light-Cured Temporary Filling Material

General Information

Temp-it® is a light-cured provisional filling material for temporary restorations. It keeps maintaining the shape of the tooth and the masticatory force until the permanent material is restored. It has three colors (yellow, blue, sky blue). It can be used as temporary restorations in any part of the inlay and onlay. It is also easy to be used because it is not sticky to the spatula and can be easily removed in one piece.

Composition

Organic Matrix : UDMA, HEMA
Inorganic Fillers : Nano silica

· Additives: Initiator, Catalyst, Stabilizer, Others

Indications

- · Temporary filling of Inlay / Onlay
- · Temporary restoration / Sealing of dental caries
- · Sealing of implant screw access cavity

Shade

Yellow, Blue, Sky blue

Precautionary Information

- 1. Check the expiration date and avoid package contamination.
- 2. Follow the instructions for use before using it.
- 3. Do not use if the material has been cured.

Application

- Finish the pretreatment of an inlay, onlay or the place where temporary restoration is required
- 2. Carefully clean and dry the cavity to be restored before applying Temp. it®.
- Place a sufficient quantity of Temp·it[®] into the cavity using a spatula or another suitable instrument.
- 4. Remove excess material around the teeth.
- 5. Light cure for 10~20 seconds with a curing light.

6. Check occlusion and adjust it using check-bite.

Caution

- Temp·it® should be used by dentists and doctors, observing the scope of application, instructions and precautions.
- Avoid the use of Phenolic substances of other phenolic containing materials in combination with Temp·it® because Phenolic substances, especially preparations containing eugenol or thymol or clove oil, interfere with the curing of Temp·it®.

- 5. Stop applying to the patients with histories of hypersensitivity such as rash and dermatitis in Temp·it®.
- 6. Be careful not to contact with eyes and use only to the oral tissue.
- Wash immediately eyes or skin with plenty of water and then consult a doctor, if they contact with materials before polymerization.
- 8. Make sure to use protective devices for the respiratory tract before surgery.
- 9. Do not use after expiration date (3 years).
- 10. If refrigerated storage is used, allow product to reach room temperature prior to use.

Storage & Use

- 1. Store Temp·it® in a dry and cool place. (Temperature: 2~27°C)
- 2. Close the lid immediately after use.
- 3. Ambient temperatures routinely higher than 27°C/80°F may reduce shelf life.
- 4. Avoid high temperature and strong light.
- 5. Expiration date is 3 years from the date of manufacture.
- 6. See outer package for expiration date.
- $7. \ Do \ not store \ materials \ in \ proximity \ to \ products \ containing \ Eugenol \ or \ thymol \ or \ clove \ oil.$
